#### 10:00 am Building and Implementing a Prototype Housing Site Information System

Local governments and development organizations across Missouri are wrestling with a variety of housing problems. Decision makers recognize there is a need for better data about housing development options. In 2017 the Lake of the Ozarks Regional Economic Development Council asked University of Missouri Extension to build a prototype housing information system. The system provides parcel level data with several overlays of risk factors, community characteristics and facilities, and other factors that influence development potential.

## **Speakers**

#### Roger Corbin—LOREDC Area Housing Task Force Co-Chair

Roger Corbin is the Vice President of the Lake of the Ozarks Regional Economic Development Council. He received an MS from the University of Nebraska at Omaha. He has been a City and Regional Planner for 25 years and is a retired U.S. Army Lieutenant Colonel.

#### Vito Lucido—Independent Living Services Manager, Delta Center for Independent Living—Panel Member

Vito Lucido is a resident of St. Louis, Missouri. Since 2007, Vito has been employed at Delta Center for Independent Living working as the Independent Living Services Manager. Among his duties, he serves as Chair of the St. Charles County Housing Team, a voluntary council dedicated to quality, affordable, universal design housing. Vito is a graduate of the University of Missouri – St. Louis with post-graduate work at both Southern Illinois University at Edwardsville and UM St. Louis, earning degrees in Public Policy Administration, Mass Communications, and Nonprofit Management & Leadership. Due to his disability acquired in 1983 when he broke his neck playing rugby, Vito has an inside understanding of the needs of people with disabilities, especially those with physical disabilities and mobility issues. Vito is a former multi-sport competitive wheelchair athlete and adaptive sport enthusiast. He is married and has two adult children.

#### Michelle Woods—Homeowner Support Manager, Habitat for Humanity—St Charles—Panel Member

Michelle Woods is the Homeowner Support Manager for Habitat for Humanity of St. Charles County and has been with the organization for over 7 years. She serves Habitat and the broader affordable housing community in her role as Chair of the Continuum of Care for St. Charles, Lincoln, and Warren Counties and as a member for the St. Charles County Housing Team. Michelle works closely with the Habitat construction manager to implement Universal Design features in all current homes.

#### Greg Lee—UD Construction Consultant, Double Diamond Construction & Development, LLC—Panel Member

Gregory Lee is Director of Development for Double Diamond Construction & Development, LLC. He has developed 18 affordable properties totaling approximately 2,000 units and overseen the construction of an additional 1,000 units as a General Contractor and Development Consultant. Greg has been involved in the development, management, and construction of affordable housing since 1996.

#### Jeff Krantz—Broker/Owner RE/MAX Lake of the Ozarks

Jeff Krantz grew up at the lake at his parents resort "Point Breeze" and began selling real estate here in 1994. Joined RE/ MAX in 1998 with his wife Melissa and began growing a team. Jeff bought into the RE/MAX franchise in 2007 and today with their partners Jason Whittle & George Bogema own the offices in Osage Beach and Camdenton. The offices currently have 96 unbelievable agents that control 44% market share within the Bagnell Dam Board. In 2017 the office had 1350 total sales and over 451 million in sales volume. The company started its own Charitable foundation in August of 2011 and to date the agents have collectively donated over \$265,000 locally. Jeff and Melissa have two sons and their daughter and son-in-law just blessed them with their first granddaughter.

#### Jason Whittle—Broker/Owner RE/MAX Lake of the Ozarks

Jason was born and raised in the Lake area. After he graduated from Camdenton in 1993 he attended Missouri State University, where he met is wife, Natalie. Wayne was the recipient of the Missouri Governor's Council on Disability 23rd Annual Inclusion Award for his work to champion the need for quality, affordable, universally designed housing throughout Missouri. He is a member of the Missouri Functional Assessment Support Team that provides rapid response to citizens with disabilities during a disaster and has worked with both FEMA and Mo. SEMA. Wayne serves on numerous boards and speaks nationally on the needs of citizens with disabilities. He brings over forty years of experience in all aspects of support to individuals with disabilities and those who support them.
