MISSOURI DEPARTMENT OF MENTAL HEALTH DIVISION OF DEVELOPMENTAL DISABILITIES

Eligibility for the Division of Developmental Disabilities is determined by a comprehensive evaluation .A developmental disability is a long term condition that significantly delays or limits mental or physical development and substantially interferes with such life activities as self-care, communication, learning, decision making, capacity for independent living, and mobility. A Comprehensive Evaluation Medical, psychological, educational and other records are reviewed for evidence of a developmental disability. Each individual is evaluated to provide information about the individual's functioning, strengths, and needs related to his or her disability. The information gathered is examined to see if there is a developmental disability which: significantly delays or limits mental or physical development, interferes with basic life activities, reflects a need for one or more specialized habilitative services, is likely to continue indefinitely, and which is attributable to intellectual disability, cerebral palsy, epilepsy, head injury, autism, a learning disability related to brain dysfunction, or any other mental or physical impairment which occurs before the age of 22, How and where to apply for services: You may apply for services or refer someone for services by calling, writing, or going to the regional office that services your county. You may contact your county agency to gather information and schedule an intake to determine eligibility for services.
